WARRANTY STATEMENT

BATTERY WARRANTY

ANA offers a 30-day Battery Warranty on all OEM models. The 30-day period will start at the time of the unit's delivery. ANA must be notified of the claim within a 60-day period of delivery date and failure. The customer must follow the normal ANA Warranty Process to submit a claim. Claims must be submitted using the PDF form provided by ANA or by the webform online at www.anacorp.com. LIGHT LOADING ISSUES

Operational issues and/or part failures due to Light Loading is NOT a warrantable repair. It is the customer's obligation and sole responsibility as the owner of the equipment to properly size the Generator/Compressor to the application, to minimize the light-loading on the Engine/Exhaust system. Routine load banking as well as manual forced regeneration cycles, when called for, should be documented as part of the overall maintenance records.

**Warranty Excludes Wear Items: filters/fluids, batteries/fuses, wheel bearings/brakes/tires/belts/hoses, bulbs/lenses, etc.*

TRAVEL TIME AND MILAGE

MAC3 TOOLS

ANA/MAC3 TOOLS ARE COVERED BY A 5-YEAR LIMITED WARRANTY ON THE CYLINDERS AND PISTONS AND A 1-YEAR LIMITED WARRANTY ON PARTS. We will Warrant all major parts for one year against manufactures defects and workmanship, less normal wear parts like Breaker Latches, Chipper Retainers, sleeves, springs, etc. Warranty is valid under the warranty coverage if products are used and operated in normal conditions. Failures due to improper application and use will not be covered. We do not cover labor, travel, freight, or downtime. Warranty Details are covered in our ANA/MAC3 Warranty Policy.
